Subject:- Allocation of work between the Chief Information Commissioner and the State Information Commissioner. Ref: Right to Information Act, 2005 (Section 15, sub section 4).

ORDER

In exercise of the powers conferred under sub section 4 of Section 15 of the Right to Information Act, 2005, the following orders pertaining to allocation of Government Departments and Public Authorities under their Administrative control between the Chief Information Commissioner and the State Information Commissioner are hereby issued:

(1) Chief Information Commissioner : Shri G. Madhavan:

- a) Raj Bhavan, High Court and General Administration (CS Establishment).
- b) Home including CID and Vigilance.
- c) Revenue, Consolidation and Rehabilitation.
- d) Town & Country Planning, Urban Estates and HUDA.
- e) Irrigation.
- f) Industries, HSIDC, HFC and Industrial Training.
- g) Tourism, Hospitality, Culture, Public Relations and Sports & Youth Affairs.
- h) Mines and Geology.
- i) HPSC, Staff Selection Commission, State Finance Commission and the State Election Commission.
- j) Transport and Civil Aviation.
- k) Law, Jails and Judicial.
- l) Finance and Planning.
- m) Technical Education.
- n) Rural Development and Panchayats.
- o) All other Departments not mentioned against serial No. (2) and the Public Authorities under their control.

(2) State Information Commissioner: Smt. Meenaxi Anand Chaudhry:

- a) Agriculture, Horticulture and Cooperation.
- b) Animal Husbandry, Dairy Development and Fisheries.
- c) Education.
- d) Health, Ayurveda and Medical Education.
- e) Power, PWD (B&R), Public Health and Architecture.
- f) Urban Development, Housing and Municipal Administration.
- g) Excise and Taxation.
- h) Forests, Wild Life Preservation and Environment.

- i) Social Welfare, Women & Child Development.
- j) Printing and Stationery.
- k) Food and Supplies.
- l) Labour and Employment.

The above distribution of work is subject to any change, alteration or modification in future. Further keeping in view administrative exigencies and the importance of the subject matter, the Chief Information Commissioner reserves the right to decide as and when the hearing should be held by the full Commission, or a combination of Chief Information Commissioner/Information Commissioners.
